- to provide high quality care and education of children in the foundation stage and
- to work within a framework that ensures equality of opportunity for all children and families.

## Terms and Conditions

**Admissions Policy:** Admission is on a first-come, first-served basis, subject to availability and adherence to our inclusivity and diversity policy. The nursery reserves the right to prioritise admissions based on various criteria, including sibling attendance and proximity to the nursery.

**Fees and Payment:** Fees are reviewed annually and are subject to change with two months' notice. Payments are due the first working day of each month, and late payments may result in late fees or suspension of services. We accept payments via standing order, bank transfer, and childcare vouchers.

**Deposit:** A deposit is required upon enrolment, which is refundable upon leaving the nursery, provided all terms and conditions have been met, including proper notice of withdrawal.

**Notice of Withdrawal:** A written notice of one calendar months is required to withdraw a child from the nursery. A minimum of three-month attendance is required to qualify for refund of deposit. Failure to provide adequate notice will result in the forfeiture of the deposit.

**Absence and Illness:** Absences due to illness or holidays do not warrant a reduction in fees. Parents are required to notify the nursery of any absences due to illness by 9 am on the day of absence.

**Health and Medication Policy:** Parents must provide a detailed health record of their child upon enrolment. Any medication required to be administered at the nursery must be prescribed by a doctor and accompanied by written instructions.

**Emergency Procedures:** The nursery has a comprehensive emergency plan for various situations. Parents are required to provide up-to-date contact information and alternative contacts in case of emergencies.

**Child Protection:** The welfare of the children is paramount. We follow strict child protection policies and cooperate with local authorities and child services as necessary.

**Behaviour Policy:** We promote positive behaviour and use constructive strategies to handle challenging behaviour. Persistent challenging behaviour may lead to a request for withdrawal if it significantly impacts the welfare of other children.

**Nutrition and Allergies:** The nursery provides nutritious meals and snacks. Parents must inform the nursery of any dietary restrictions or allergies. The nursery endeavours to accommodate special dietary requirements within reason.

**Personal Belongings:** The nursery cannot be held responsible for loss or damage to personal belongings. Children are discouraged from bringing valuable items to the nursery.

**Privacy and Data Protection:** Personal information provided to the nursery is treated with the utmost confidentiality and in compliance with GDPR. Information will only be shared with authorized personnel and government bodies as required by law.

**Amendments to Terms and Conditions:** The nursery reserves the right to amend these terms and conditions. Parents will be given notice of any significant changes.

**Complaints Procedure:** We aim to provide the highest level of care. However, should parents have any concerns or complaints, they are encouraged to follow our formal complaints procedure, details of which are available upon request.

**Termination of Service:** The nursery reserves the right to terminate the provision of services under certain circumstances, including non-payment of fees, failure to comply with terms and conditions, or if it is deemed in the child's best interest.

**Clothing:** We provide protective clothing for children while doing messy activities, but we encourage parents to bring in change of clothing (this includes under-wears) just in case children's clothes gets dirty.

**Late Pick-ups:** If there is an occasion where you are unable to collect your child on time at the end of their session, we require a minimum of one hour's notice by telephone. This allows us to ensure that your child continues to receive care and supervision until you arrive.

A fee may be charged for late collection, and the amount may increase depending on the duration of the delay.

- All lateness fees must be settled before your child's next scheduled session.
- Please note that in exceptional circumstances, the management reserves the right to waive the lateness fee at their discretion.

We understand that unforeseen situations can arise, and we appreciate your communication in these instances to help us manage our care responsibilities effectively.

## Payments

At Happi Feet Nursery, we believe in transparent and comprehensive pricing that reflects the quality of care and education we provide. Our fees are structured to include everything your child needs for a fulfilling day at nursery—nutritious meals, healthy snacks, fresh milk, engaging activities, and a warm, welcoming environment.

Our fees vary based on the age of your child and the type of attendance (full days or half days). Below is a breakdown of our fee structure to help you find the option that best suits your family's needs.

### **Additional Options**

- Emergency Extra Day: Available upon request, subject to availability.
- Regular 15H (Funding) 2Y Olds & 3Y Olds: Please inquire for details.
- Regular Funding 30H: Special sessions for eligible families.
- Extra Sessions: Can be arranged, invoiced separately.

**Note:** Our prices include all meals and activities. Fees are payable in advance by standing order. The nursery is closed for bank holidays and the Christmas period, but fees are calculated to take these closures into account.

### **Additional Financial Information**

- Application Fee: A one-time non-refundable fee of £60 is required with your application.
- Deposit: A deposit (refundable under terms) of £200, £150, or £100 is required at registration, based on the number of sessions.
- Late Payment Fees: Charges apply for late fee payments and late pickups, encouraging timely payments and pickups.
- We aim to offer competitive rates while ensuring the highest quality of care and education for your child. Our fees are reviewed annually, and we will provide a minimum of **one** months' notice of any changes.
- We accept childcare vouchers. Please contact our Nursery Manager for further details.

### **Administration Fee for Late Payments and Cancellations**

If a payment is late by 1 to 5 working days, an administration fee of £20 will be applied.

For payments that are 6 or more working days late, the administration fee increases to £30.

An administration fee of £30 will be incurred for any cancellation of additional sessions that is not made with at least 24 hours' notice.

In the event that your child cannot be collected promptly at the end of a session, a minimum of one hour's notice by telephone is required. A lateness fee is liable that could increase depending on how late the child is eventually picked up. Lateness fees due before the child's next session. The Management may use their discretion to waive this fee in exceptional circumstances.
